

Terms & Conditions

TOUR ORGANIZER: Saints Peter and Paul Orthodox Mission, Inc., doing business as "IkonTour," is the organizer and manager of this pilgrimage tour.

TOUR PRICE: The price of the tour is quoted in US dollars. The Land Only tour price is \$1,655 USD per person, twin share, based on a minimum of 12 passengers and costs, charges, tariffs, rates, prices, taxes, levies, and exchange rates as of 1/28/2011. The single supplement is \$240 USD.

WHAT'S INCLUDED: Eight nights' accommodation in three-and-four-star hotels (*except for one night in Studenica Monastery*) with *en suite* toilet and bath or shower, based on twin share; half board (breakfast and supper) daily, including dinner with tamburiza music on last night; airport transfers and ground transportation by private, chauffeur-driven touring coach; master iconographer guide/lecturer; full-time, professional tour escort; 50 x 70 cm, full-color "Sanctuaries" map of Serbia; guidebook and travel diary customized to our itinerary; souvenir tote bag and luggage tag.

WHAT'S NOT INCLUDED: Round-trip, international airfare to Belgrade, Serbia; lunches and snacks; passport fees; travel insurance; medical expenses; laundry; phone calls; mini-bar items; tips; items of a personal nature; baggage handling; excess baggage charges; and independent entertainment and excursions. The tour price also does not cover costs and expenses, including the return to your home, if you leave the tour, either of your own volition or at our request, or due to death or illness, or as a consequence of the official action of U.S. authorities or the government of any country visited.

PARTICIPATION: The tour is moderately strenuous. There is a considerable amount of walking on both level and hilly terrain, and stairs to climb. Passengers requiring any special assistance must be accompanied at all times by an able-bodied companion to provide such assistance. "IkonTour" reserves the right at our absolute discretion to refuse to carry any person whose conduct causes disruption of the tour. In such cases full cancellation penalties will apply and "IkonTour" shall have no further responsibility to that passenger.

RESERVATION & FINAL PAYMENT: A non-refundable deposit of \$300 USD per person is required to secure your reservation. Reservations are first-come, first-served and are limited to 20 passengers. The balance of your tour payment is due no later than 8 July 2011, or immediately upon booking your tour after 8 July 2011. Please make checks and money orders payable to Saints Peter & Paul Orthodox Mission, Inc. Your payment is not deemed made until it is received. "IkonTour" reserves the right to cancel the reservation and impose cancellation penalties should payments not be received within the specified periods.

CANCELLATION POLICY: If you cancel your trip 90 days or less prior to departure, the following cancellation penalties will apply:

OPTIONAL TRIP INSURANCE: At an additional cost, "IkonTour" offers 24-hour, worldwide travel protection plans that reimburse you up to 100% of the insured amount of the tour cost for any financial loss you incur if you must cancel any time before the trip or prior to your return due to illness, injury, or death of yourself, a family member, or traveling companion. It also covers

trip interruption, travel delay, accident and sickness medical expenses, emergency evacuation, baggage and personal effects, baggage delay, and accidental death and dismemberment. Certain exclusions apply and the plan is available only to citizens of the U.S. and Canada. (See the plan brochures for details.) **You do not have to purchase cancellation coverage to receive full coverage in all other categories.** If you do not wish to purchase travel insurance protection, "IkonTour" requires that you initial your declination of coverage on your enrollment form.

TOUR CANCELLATION: If "IkonTour" must cancel the tour due to lower than minimum required enrollment or other circumstances beyond our control, your tour payment will be refunded in full. "IkonTour" is not responsible for any other travel arrangements affected due to our cancellation.

DELAYED OR CANCELED FLIGHTS: Lodging, meals, and other traveling expenses occasioned by flight delays or cancellations are your sole responsibility.

BAGGAGE ALLOWANCE: You are limited to one piece of luggage and you are responsible for handling your own luggage throughout the tour. Consult your airline for size and weight restrictions.

ITINERARY DEVIATIONS: Should unforeseen circumstances make changes necessary, "IkonTour" reserves the right to vary itineraries, and substitute hotels and other travel arrangements, without notice.

TRAVEL DOCUMENTS: All passengers are required to have a passport valid for 6 months beyond the date of their return to their home country. No visa is required for U.S. and Canadian citizens for visits of less than 90 days in Serbia/Kosovo. It is the responsibility of each individual participant to make sure all of his/her legal documents necessary for travel are valid.

RESPONSIBILITY: "IkonTour" acts only as an agent for you in arranging for transportation and certain food and lodging on this trip. You agree that (1) you will not claim that "IkonTour" is a common carrier or an agent for one; and (2) "IkonTour" will have no responsibility or liability for (a) any act or omission of any hotel, restaurant, carrier, or other third person or any such person's servants or employees; (b) any delays, missed planes or other carrier connections; (c) damage or injury to person, or loss of or damage or injury to property; or (d) any defect or failure of any nature, however caused, of any product, machine, or food. Of course, you will have various contracts with airlines, common carriers, hotels, restaurants, and similar persons. Your rights against them and other third persons, contractual and otherwise, are your only source of recourse on account of anything they do or fail to do. You promise not to make any claim against "IkonTour" related to any act or omission of any third person, and you will indemnify "IkonTour" and hold it harmless if any person seeks contribution or indemnity from it in connection with any claim relating to you, even if "IkonTour" was or is claimed to have been negligent in whole or in part. Further, if you decline trip insurance coverage, you assume full responsibility for your refusal of trip insurance. Any disputes or claims that may arise relating to this contract or to events during the tour will be settled by arbitration in the State of Arizona. The law of the State of Arizona will govern any contract dispute. The invalidity of any of the provisions hereof shall not affect the validity of any of the other provisions, and the agreements shall be construed as though such invalid provision had never been contained herein.
